



Fellow Application

Being a Fellow of the Association for Healthcare Documentation Integrity is an honor. It signifies that you have achieved a balance of successful activities in your profession that goes far beyond regular transcription practice.

The criteria adopted by the AHDII Board of Directors, which AHDII members must meet in order to earn the designation of Fellow of the Association for Healthcare Documentation Integrity (AHDII-Fellow), strengthen the fellowship designation, enhancing its prestige and value to those who earn the right to use the initials.

How to Become a Fellow of AHDII

To become recognized as a fellow in AHDII, you must earn at least 50 fellowship points in the five years immediately preceding the application and be a “Practitioner” member as set forth in the AHDII bylaws at the time the application is submitted. These points may be earned in eight different categories as shown on the application and must be earned in at least five categories.

There is a limit to the number of points you can obtain in each category. Thus, qualified fellows must demonstrate a balance between practice duties, professional experience, leadership, and community involvement. When filling in the application, please include all activities/accomplishments that pertain to the category, however, enter only up to the maximum points allowed for that category. As a result, to be an AHDII-Fellow, a successful candidate is active in and knowledgeable of many areas, not just one or two.

Fellow Application

To be considered for this prestigious honor, please examine the eight categories for fellowship. As you earn points within the different categories enter them on the application. As soon as you have earned a total of 50 points, in at least 5 of the 8 categories, complete the application and send it, along with the non-refundable application fee, to AHDI, Attn: Tina Wilson, Professional Programs Specialist, 4230 Kiernan Ave . Suite 130, Modesto, CA 95356. If you have any questions please do not hesitate to contact the Professional Programs department of AHDI.

Remember, the 50 points must be earned within the five years immediately preceding the date of application, and your membership in AHDI must be in the “Practitioner” category.

In the event that your application is reviewed and denied approval, you will receive a letter detailing what is needed to be approved. You will have one year from the date on the denial letter to resubmit your application at no additional fee. After that date, you will have to reapply and include the \$100 non refundable application fee.

- ❖ Formal presentations to peers - 2 points each

- ❖ Each local chapter or university award - 3 points per award
- ❖ Other Awards - 1 point per award

- ❖ Registered Medical Transcriptionist - 5 points per year
- ❖ Other allied healthcare credential - 3 points per year
